

**THE TOWNSHIP OF BELLEVILLE REQUEST FOR PROPOSALS FROM
FIRMS/INDIVIDUALS INTERESTED IN PROVIDING
PEST/ RODENT CONTROL SERVICES
FOR THE PERIOD JANUARY 1, 2024, THROUGH DECEMBER 31, 2025**

Introduction

Pursuant to the Fair and Open Process described under N.J.S.A. 19:44A-1, et seq., the Township seeks Request for Proposals (“RFP”) from firms/individuals that wish to provide Pest / Rodent Control Service for a contract period beginning on January 1, 2024, and ending on December 31, 2025.

All necessary documents can be downloaded from the official Belleville website, www.bellevillenj.org, Copies of this standardized submission requirements and selection criteria are also on file and available from the Office of the Township Clerk.

All candidates are required to comply with N.J.S.A. 10:5-31 et seq and N.J.A.C. 17:27 et seq. as amended. (Affirmative Action). Each candidate shall submit proof of business registration with the New Jersey Division of Taxation (P.L. 2004, C.57) prior to the award of contract but preferably with their proposal.

**SPECIFICATIONS FOR
PEST/RODENT CONTROL SERVICE**

SERVICE CONTRACT WILL BE FOR A 24-MONTH PERIOD BEGINNING ON JANUARY 1, 2024 THROUGH DECEMBER 31, 2025.

All work is to be performed during regular business hours 8:00 a.m. to 4:00 p.m. If the Township of Belleville requests overtime work, we agree to pay the difference between regular and overtime labor.

All vendors’ responding to the specification place of business must be within 25 miles of the Township of Belleville Town Hall to minimize response time in an emergency.

ANY AND ALL EXCEPTIONS TO THESE SPECIFICATIONS MUST BE LISTED ON A SEPARATE PIECE OF PAPER AND MUST BE SUBMITTED WITH THE BID.

The Contractor agrees to perform 24-hour minor emergency callbacks.

PROPOSAL FORM

We have carefully examined the specifications for **PEST/RODENT CONTROL SERVICE** for the Township of Belleville and agree to furnish this service for the following price:

In addition to the foregoing terms and conditions, the Contractor agrees to indemnify, defend and save harmless, the Township of Belleville and its elected officials, officers, agents and employees against and from all suits and costs of every description, including but not limited to cost of attorney representation, and from all damages which may be brought against the Township of Belleville or any of its officers, agents and employees, arising out of, or resulting from, the work that is the subject of this Agreement. The indemnification provided by the Contractor shall include indemnification from any alleged or actual fault of negligence on the part of the Township of Belleville or any of its elected officials, officers, agents and employees.

ITEM #1: PEST/RODENT CONTROL IN TOWNSHIP BUILDINGS/PROPERTIES

The Township of Belleville is seeking bids to provide regular pest control services (inspections and treatments) four (4) times a year, for the control of all categories of roaches, flies, silverfish, clover mites, paper mites, bedbugs, lice, pavement ants (**excluding** carpenter ants), wasps, bees (**including** carpenter bees), mice and rats. This bid shall also include *free emergency service* during normal working hours (8:00 a.m. to 4:00 p.m., Monday through Friday).

Pest Control Services are required for all offices, public areas, including food and water areas and rest rooms, for the below listed municipal locations.

The exterminator shall establish effective rodent control and insect control with proper bait stations, sticky trays, traps etc. as warranted to gain control at locations where necessary.

The exterminator shall quote a general cost per linear foot price for the treatment of Termites. There is no minimum or maximum footage implied or guaranteed.

These prices bid under this service program **will not include** the control of carpenter ants or the control of flying insects such as mosquitoes or gnats. However, from time to time, the Township may call the exterminator for a flat fee to treat a particular area invested with these pests.

This service program will include additional service calls at the above locations that may be necessary to maintain proper pest control and will be provided at no additional charge to the Township.

Before application is made, the exterminator must notify the Township of Belleville of any precautionary measures to be undertaken by the Township.

It will be the exterminator's responsibility to visit the sites and inspect the areas to be serviced. No special consideration will be given after the contract is awarded because of the exterminator's failure to be knowledgeable of all conditions existing at the various sites.

The Township may call the exterminator for a flat fee to treat other Township buildings/properties as needed.

D. AMERICANS WITH DISABILITIES ACT OF 1990
Equal Opportunity for Individuals with Disability

The contractor and the Township, (hereafter "owner") do hereby agree that the provisions of Title 11 of the Americans With Disabilities Act of 1990 (the "Act") (42 U.S.C. 5121 01 et seq.), which prohibits discrimination on the basis of disability by public entities in all services, programs, and activities provided or made available by public entities, and the rules and regulations promulgated pursuant there unto, are made a part of this contract.

In providing any aid, benefit, or service on behalf of the owner pursuant to this contract, the contractor agrees that the performance shall be in strict compliance with the Act.

In the event that the contractor, its agents, servants, employees, or subcontractors violate or are alleged to have violated the Act during the performance of this contract, the contractor shall defend the owner in any action or administrative proceeding commenced pursuant to this Act.

The contractor shall indemnify, protect, and save harmless the owner, its agents, servants, and employees from and against any and all suits, claims, losses, demands, or damages, of whatever kind or nature arising out of or claimed to arise out of the alleged violation.

The contractor shall, at its own expense, appear, defend, and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the owner's grievance procedure, the contractor agrees to abide by any decision of the owner which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the owner, or if the owner incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the contractor shall satisfy and discharge the same at its own expense.

The owner shall, as soon as practicable after a claim has been made against it, give written notice thereof to the contractor along with full and complete particulars of the claim. If any action or administrative proceeding is brought against the owner or any of its agents, servants, and employees, the owner shall expeditiously forward or have forwarded to the contractor every demand, complaint, notice, summons, pleading, or other process received by the owner or its representatives.

It is expressly agreed and understood that any approval by the owner of the services provided by the contractor pursuant to this contract will not relieve the contractor of the obligation to comply with the Act and to defend, indemnify, protect, and save harmless the owner pursuant to this paragraph.

Non Construction Contracts
