

**THE TOWNSHIP OF BELLEVILLE REQUESTS PROPOSALS FROM
BUSINESS ORGANIZATIONS/INDIVIDUAL INTERESTED IN PROVIDING
“PURCHASE OF ASPHALT MATERIALS” FOR THE TOWNSHIP
FOR THE PERIOD JANUARY 1, 2024, THROUGH DECEMBER 31, 2025**

Introduction

Pursuant to the Fair and Open Process described under N.J.S.A. 19:44A-1, et seq., the Township seeks proposals from business organizations/individuals who provide Purchase of Asphalt Materials to the Township. These services will commence on January 1, 2024, and end on December 31, 2025, in response to this Request for Proposals.

All necessary documents can be downloaded from the official Township of Belleville website www.bellevillenj.org. Copies of this standardized submission requirements and selection criteria are also on file and available from the Office of the Town Clerk.

All candidates are required to comply with N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 as amended. (Affirmative Action). Each candidate must submit proof of business registration with the New Jersey Division of Taxation (P.L. 2004, C.57) prior to the award of contract but preferably with their proposal.

The successful candidate will provide the Township with services related, but not necessarily limited to:

1) INTENT

The intent of the Township of Belleville is to seek a contractor/supplier to provide asphalt material for pick-up by Township of Belleville personnel for a **twenty (24) month period, beginning on January 1, 2024 through December 31, 2025**. No minimal order requirements are allowed.

The material supplied must be in accordance with all applicable Federal, State and Local requirements.

2) WORK SCHEDULE

Contractor/Supplier will be available to supply materials for pick-up by the Township of Belleville, Monday through Friday from 7:30 a.m. to 4:00 p.m.

3) PRICING

Bid Prices are to remain firm for the term of the contract with no exceptions.

Bid prices shall include the cost of loading the Township’s trucks at point of supply.

4) AWARD OF CONTRACT

Award of Contract will be made to the lowest responsive, responsible bidder. Award will be based on the lowest aggregate total extended prices per category. A vendor may receive an award for one or more categories.

5) DELIVERY/PICKUP

If bidder’s pickup location is different from bidder’s mailing address, both addresses must be indicated on the proposal form.

Acceptance of any material will be based on inspection by representatives of the Township of Belleville either prior to or after loading said materials.

The Contractor's pick-up location shall allow for Township vehicles to load within forty-five (45) minutes of arrival. For failure of the Contractor's facility to allow Township vehicles to load asphalt within forty-five (45) minutes may result in the assessment of liquidated damages in the amount equal to \$150.00 per hour to be prorated based on total time that the vehicle is required to wait.

The successful bidder must accept clean, used recyclable asphalt material at no cost to the Township of Belleville.

6) ASPHALT PRICE ADJUSTMENT

If applicable, asphalt price index adjustment calculation is to be provided with each invoice.

7) BIDDERS PLANT/FACILITY, DISTANCE FROM TOWNSHIP

Bidders asphalt pick-up location shall be located within twenty (20) road miles from the Township of Belleville's Public Works Garage located at 429 Stephens Street, Belleville, New Jersey as determined by Google Maps.

The successful candidate shall be required to comply with the following insurance requirements:

- a. The Contractor shall be required to carry full insurance including comprehensive general liability; workman's compensation insurance; which shall cover all operations of the Contractor, its employees, agents and servants hereunder, and; motor vehicle and equipment used by the Contractor in connection with the Contractor's operations under the Contract; Contractor shall provide professional liability (errors& omissions) insurance for claims arising from any negligent performance of contractors' services pursuant to the agreement in the amount of \$1,000,000 per claim. Said insurance, by endorsement, shall fully protect the Township of Belleville from liability.
- b. Certificates naming the Township of Belleville as an additional named insured, and evidencing such insurance coverage, shall be filed with the Township Clerk prior to the commencement of operations hereunder by the Contractor.

The following Certificates of Insurance must be furnished:

- I. Worker's Compensation;
Part Two – Statutory
- II. Comprehensive General Liability:

A. Minimum limits: \$1,000,000.00;
Combined Single Limit Coverage to include:
Premise / Operations; Independent Contractors;
Product / Completed Operations;
Contractual; Personal Injury;
Broad Form Property Damage;
Township of Belleville as additional insured.

B: Comprehensive General Liability must be maintained for at least one year after completion of the contract and its acceptance by the Township of Belleville.

III. Professional Liability Insurance (Errors & Omissions)

A. Contractor shall provide professional liability (errors& omissions) insurance for claims arising from any negligent performance of contractors' services pursuant to the agreement in the amount of \$1,000,000 per claim.

The certificate of insurance shall designate the Township of Belleville as an additional insured and shall contain a thirty (30) day notice of cancellation whereby the Township Clerk will be provided with a written notification of cancellation. Said insurance must be paid for a minimum of six (6) months into the contract period at the time of the contract.

It is understood and agreed that the Contractor is an independent Contractor and not an employee of the Township of Belleville.

The Contractor agrees to indemnify and hold harmless the Township of Belleville, the Board of Commissioners of the Township of Belleville, and all of its officers, agents and employees of and from any and all liability for damages for injury to person and property, including death and against and from all suits and actions and all costs, damages and change of whatsoever kind of nature, including attorneys' fees to which the Township of Belleville maybe put for or on account of any injury or alleged injury to person, including death, or property, resulting from the performance of the Contractor's operations under this Contract, or by or in consequence of any neglect or omission on the part of the Contractor in the performance of operations under the Contract, whether such operations, or in the absence thereof, be by the Contractor or anyone directly or indirectly employed by the Contractor.

The Contractor shall hold the Township of Belleville harmless for damages to the Contractor's Equipment utilized during the term of this Contract.

Programs of self-insurance are not acceptable.

4. Cost competitiveness.

This RFP does not commit the Township award any contract to any respondent, only one respondent, or more than one respondent, nor does it require or bind the Township to follow any other procurement or process for obtaining services or award any contract for any set period of time. Any award(s) shall be made to a vendor whose response is most advantageous, price and other factors considered.

Regardless of the above, or the terms of any proposal received, the Township may, at its sole discretion, negotiate with any respondent deemed qualified for the provision of these services as a result of a submission received in response to this RFP.

D. AMERICANS WITH DISABILITIES ACT OF 1990

In any and all complaints brought pursuant to the owner's grievance procedure, the contractor agrees to abide by any decision of the owner which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the owner, or if the owner incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the contractor shall satisfy and discharge the same at its own expense.

The owner shall, as soon as practicable after a claim has been made against it, give written notice thereof to the contractor along with full and complete particulars of the claim, If any action or administrative proceeding is brought against the owner or any of its agents, servants, and employees, the owner shall expeditiously forward or have forwarded to the contractor every demand, complaint, notice, summons, pleading, or other process received by the owner or its representatives.

H. MANDATORY BUSINESS REGISTRATION LANGUAGE
Non Construction Contracts

All contractors and subcontractors must provide a Business Registration Certificate when seeking to do business with the State of New Jersey, and other public agencies in this state. Failure to submit proof of registration requires mandatory rejection of a bid as a non-waivable defect. Proof of registration must be received before the contract is issued for non-bid contracts: such as contracts exempt from public bidding that are over the bid threshold, professional services, and extraordinary unspecifiable services, and purchase orders that are under the bid threshold.
