Introduction

Pursuant to the Fair and Open Process described under N.J.S.A. 19:44A-1, et seq., the Township seeks Request for Proposals (“RFP”) from firms/individuals that wish to provide Purchase of Water Supplies Service for a contract period beginning on January 1, 2024, and ending on December 31, 2025.

All necessary documents can be downloaded from the official Belleville website, www.bellevillenj.org, Copies of this standardized submission requirements and selection criteria are also on file and available from the Office of the Township Clerk.

All candidates are required to comply with N.J.S.A. 10:5-31 et seq and N.J.A.C. 17:27 et seq. as amended. (Affirmative Action). Each candidate shall submit proof of business registration with the New Jersey Division of Taxation (P.L. 2004, C.57) prior to the award of contract but preferably with their proposal.

SPECIFICATIONS FOR THE PURCHASE OF WATER SUPPLIES

The term of this contract is for twenty-four (24) months beginning on January 1, 2024 through December 31, 2025.

- 1) All orders are on an as needed basis.
- 2) All orders require a Township of Belleville purchase order voucher at the time of order/purchase.
- 3) All supplies must be stock items.
- 4) All material is to be AWA and is further described on the proposal form.
- 5) All material must be lead free.
- 6) In the case of an emergency, an authorized member of the Public Works or Purchasing Departments may place a verbal order.
- 7) All items shall be net, with no additional shipping or handling charges added.
- 8) All deliveries shall be made within 10 days of receipt of the purchase order.
- 9) All receipts shall show the original and the discounted price of each item.

Items may be individually awarded to separate vendors. If you do not carry a specific item, put "NO BID" in price column.
