

**THE TOWNSHIP OF BELLEVILLE REQUEST FOR PROPOSALS FROM  
FIRMS/INDIVIDUALS INTERESTED IN PROVIDING  
VEGETATIVE WASTE REMOVAL SERVICES  
FOR THE PERIOD JANUARY 1, 2024, THROUGH DECEMBER 31, 2025**

**Introduction**

Pursuant to the Fair and Open Process described under N.J.S.A. 19:44A-1, et seq., the Township seeks Request for Proposals (“RFP”) from firms/individuals that wish to provide Vegetative Waste Removal Services for a contract period beginning on January 1, 2024, and ending on December 31, 2025.

All necessary documents can be downloaded from the official Belleville website, [www.bellevillenj.org](http://www.bellevillenj.org), Copies of this standardized submission requirements and selection criteria are also on file and available from the Office of the Township Clerk.

All candidates are required to comply with N.J.S.A. 10:5-31 et seq and N.J.A.C. 17:27 et seq. as amended. (Affirmative Action). Each candidate shall submit proof of business registration with the New Jersey Division of Taxation (P.L. 2004, C.57) prior to the award of contract but preferably with their proposal.

**VEGETATIVE WASTE REMOVAL SPECIFICATIONS**

**INTENT**

The intent of the Township of Belleville is to seek a contractor to dispose of it vegetative waste collected within the township during the spring, summer and fall season collection program.

**PERMIT/LICENSE REQUIREMENTS**

The successful bidder must have all required New Jersey Department of Environmental Protection permits and any additional necessary permits, licenses, registrations or reports required for vegetative waste disposal to operate. Contractor must also have the appropriate capacity to handle the quantity of recyclables generated from the Township of Belleville. A copy of the operating permit for the facility must be included with the bid proposal and the facility must be located within 20 miles of the Public Works yard.

**ESTIMATED VOLUME/QUANTITIES**

Estimated amounts are:

- 3,500 cubic yards of non-compacted leaves.
- 3,000 cubic yards of brush/tree parts.
- 100 cubic yards of grass.
- 4,000 cubic yards of mixed yard waste (tree parts/ brush/ yard waste).
- 20 cubic yards of stumps and logs.

The quantities noted are based on annual amounts. No minimum quantity is guaranteed. Changes in quantities will not result in changes in unit prices submitted by the lowest responsible bidder(s) awarded this contract.

**WORK SCHEDULE**

The bidder’s work schedule shall not interfere with the normal operation at the Township’s facility. The normal daily work schedule shall be Monday through Friday, 7:30 am till 4:00pm.

**TIME AND PAYMENT**

All material will be measured by cubic yard. Payment will be made for cubic yards actually disposed of at the unit price bid for each individual item.

**Scope of Work**

- 1) The minimum of containers to be provided each day for loading:  
Brush: 30 – 50 Yard Containers / Leaves and Grass: 30 – 100 Yard Containers
- 2) All loaded containers shall be picked up within 2 working days and empty containers left in their place.
- 3) All containers shall be in compliance w/NJDOT.
- 4) Brush must be taken to a fully approved NJ DEP Certified Class B Recycling Facility that has been generally approved. Grass and leaves must be brought to a fully approved NJ DEP Certified Class C Recycling Facility that has been generally approved.

**Definitions**

Container: A 20, 40 or 50 cubic yard container with an open top constructed of steel, with one hinged door at the rear and four (4) steel roller wheels for ease of movement. All containers shall be structurally sound and neat in appearance.

Dump Trailer: A minimum of 65 cubic yards with an open top. All trailers shall be structurally sound and neat in appearance.

Walking Floor Trailers: A minimum of 100 cubic yards with an open top. All trailers shall be structurally sound and neat in appearance.

Collection Equipment.

The contractor shall provide an adequate number of vehicles for daily transportation of all containers containing brush, leaves, grass and mixed yard waste. In addition, all equipment shall be maintained in good working and operating condition.

5. Cost competitiveness in light of all of the above factors.

**D. AMERICANS WITH DISABILITIES ACT OF 1990**

The owner shall, as soon as practicable after a claim has been made against it, give written notice thereof to the contractor along with full and complete particulars of the claim. **H. MANDATORY BUSINESS REGISTRATION LANGUAGE**  
**Non Construction Contracts**
