

**THE TOWNSHIP OF BELLEVILLE REQUEST FOR PROPOSALS FROM
FIRMS/INDIVIDUALS INTERESTED IN PROVIDING
“REPAIRS AND MAINTENANCE OF OVERHEAD DOORS”
FOR THE PERIOD JANUARY 1, 2026, THROUGH DECEMBER 31, 2025**

Introduction

Pursuant to the Fair and Open Process described under N.J.S.A. 19:44A-1, et seq., the Township seeks Request for Proposals (“RFP”) from firms/individuals that wish to provide Repair and Maintenance of Overhead Doors Service for a contract period beginning on January 1, 2024, and ending on December 31, 2025.

All necessary documents can be downloaded from the official Belleville website, www.bellevillenj.org, Copies of this standardized submission requirements and selection criteria are also on file and available from the Office of the Township Clerk.

All candidates are required to comply with N.J.S.A. 10:5-31 et seq and N.J.A.C. 17:27 et seq. as amended. (Affirmative Action). Each candidate shall submit proof of business registration with the New Jersey Division of Taxation (P.L. 2004, C.57) prior to the award of contract but preferably with their proposal.

SPECIFICATIONS FOR REPAIR AND MAINTENANCE OF OVERHEAD DOORS

The Township of Belleville has varied needs for the repair and maintenance of the many overhead doors on various Township buildings. The purpose of this specification is to set forth the service requirements to be met by a prospective bidder should he be awarded the contract to maintain and repair these overhead doors, parts and similar items, owned by the Township.

SERVICE CONTRACT WILL BE FOR A (24) TWENTY-FOUR MONTH PERIOD BEGINNING ON JANUARY 1, 2024 THROUGH DECEMBER 31, 2025.

The successful bidder is required to have any and all licenses as may be required for this work.

All work shall be performed in a professional and workmanlike manner. The work area shall be kept tidy, and all rubbish and debris shall be removed by the successful bidder at the completion of work or the end of the work day, whichever occurs first.

The successful bidder must be able to respond to calls within two (2) working days. **In the event of an emergency, the response time shall be within two (2) hours from placement of the first call.** The bidder must provide seven (7) days a week service.

The successful bidder shall first attempt to repair the doors and only if problems are such that repairs are impossible shall he actually replace the existing doors and/or parts with new ones.

Prior to actually doing any work, except in instances of an emergency, the vendor shall present an all-inclusive price quote to the department head for approval. Said approval shall be in the form of a signed purchase order. All prices shall be in accordance with prices bid.

Payment shall be made for time at the actual job site only. Travel time will not be paid for any reason.

When the successful bidder responds to a call, he shall examine the other doors in close proximity to the door he is called to repair to determine that the other doors are in good working condition. The successful bidder shall make minor adjustments at that time and report any major deficiencies to the using department.

Experienced Mechanic shall be defined as a mechanic who is fully trained in the operation of such doors and shall have any and all necessary educational backgrounds available in the trade. He shall have at least two (2) years of on the job experience working on overhead doors.

Helper shall be defined as a person who lacks the necessary education, training or work history/background to be an experienced mechanic.

The award of the contract shall be made to the lowest, responsible bidder. The lowest, responsible shall be determined as the bidder with the lowest costs overall for items #1 through #4 on the bid sheet.

Costs of materials plus percentage mark-up shall be defined to mean the successful vendors own cost paid to his suppliers plus mark-up the bidder wishes to have added to his cost to pay his overhead, profit, etc. the successful vendor may be requested at any time by the Township of Belleville to prove his stated cost by providing a copy of the vendors own invoice from his suppliers. All invoices to the Township of Belleville will show the vendors own cost plus the percentage markup as bid.

The successful bidder shall be an independent contractor and not an employee of the Township of Belleville. He shall carry a full inventory of supplies and equipment so as to adequately provide the services required.

Nothing contained herein shall be so construed to prevent the Township of Belleville from using its own employees to affix such repairs internally as the Township may be able to perform.

It is the intent of the Township of Belleville to award this bid on an open-ended basis with funds being encumbered at the time each service call is placed, contingent upon the availability of funds in the appropriate municipal budget year.

No minimum purchase is implied or guaranteed.

The indemnification provided by the Contractor shall include indemnification from any alleged or actual fault of negligence on the part of the Township of Belleville or any of its elected officials, officers, agents and employees.

2. Ability to perform the task in a timely fashion, including staffing and familiarity with the subject matter; and
3. Ability to be available with the appropriate personnel at all times necessary to accomplish the representation;
4. The cost and expense that will be necessary to familiarize the attorney with the legal issues arising in the prosecution of municipal offenses; and
5. Cost competitiveness in light of all of the above factors.

7. Other factors, if demonstrated to be in the best interest of the Township.

D. AMERICANS WITH DISABILITIES ACT OF 1990

If any action or administrative proceeding results in an award of damages against the owner, or if the owner incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the contractor shall satisfy and discharge the same at its own expense.

The owner shall, as soon as practicable after a claim has been made against it, give written notice thereof to the contractor along with full and complete particulars of the claim. If any action or administrative proceeding is brought against the owner or any of its agents, servants, and employees, the owner shall expeditiously forward or have forwarded to the contractor every demand, complaint, notice, summons, pleading, or other process received by the owner or its representatives.

It is expressly agreed and understood that any approval by the owner of the services provided by the contractor pursuant to this contract will not relieve the contractor of the obligation to comply with the Act and to defend, indemnify, protect, and save harmless the owner pursuant to this paragraph.
